

HURON VALLEY TENNIS CLUB**2023-24 SEASONAL COURT TIME**

Seasonal court time for 2023 begins Sun., September 10, and ends Sat., May 11. The club is now accepting reservations from regular members. Those wishing to keep the same court and time they had in 2022-23 should submit their reservation by August 15. Only written applications for reservations will be accepted.

Reservations for seasonal court time are firm commitments for the entire indoor season and cannot be canceled. A group is responsible for the entire court payment, even if one or more of its members withdraw from the group.

Members with seasonal reservations are billed monthly and must pay for the courts even if unable to play. On days when members cannot use their courts, the club will sell the reservations, if possible, and credit the members' accounts. There is no seasonal court time on four holidays: Nov. 23, Dec. 24, Dec. 31, and Jan 1. The club is closed on Dec. 25.
